STATE AND FEDERAL PRIMARIES AND COUNTY GENERAL

The Carroll County Election Commission announces VOTING for the State and Federal Primaries and County General Elections on Election Day, August 1, 2024. Registered voters, in Carroll County, may cast a ballot on Election Day by personal appearance at their designated polling location.

State law requires voters to have Federal or State government issued photo ID to vote, unless an exception applies. College student IDs will not be accepted. The voters must have photo identification when they present themselves to vote. This includes Early Voting, which is ONLY at the election office, and Election Day at your assigned polling place.

EARLY VOTING (only in the Election Office) FOR THE AUGUST 1, 2024 ELECTIONS is in progress now through Saturday, July 27. Weekday voting is 8:30 a.m.-4 p.m. Saturday voting is 9 a.m.-NOON.
