# Practicing fire safety during the winter months

According to the National Fire Protection Association, “home fires occur more in the winter than in any other season, and heating equipment is involved in one of every six reported home fires, and one in every five home fire deaths.”

That is why it is important to take extra precautions while dealing with heating elements during winter weather. Caleb Wohlers, of the Missouri Valley Fire Department, said that there is typically

more use of space heaters to keep occupied areas warmer, and in some cases, heat sources used to keep pipes from freezing or to thaw out pipes that are already frozen.

“It’s important to

remember some simple safety tips when doing so,” Wohlers said. “Don’t have combustibles nearby and don’t have them plugged into powerstrips or light duty extension cords. Use them as intended, make sure they can’t fall over, and monitor their use. In most cases, if it is a heater that uses fuel or an open flame, they are not intended for indoor use, and carbon monoxide poisoning can become an issue.”

Known as the “silent killer”, carbon monoxide is a colorless, odorless, tasteless, and non-irritating gas that

can severely kill or injure. According to the Mayo Clinic, signs and symptoms of carbon monoxide poisoning include dull headache, dizziness, nausea or vomiting, shortness of breath, confusion, blurred vision, and loss of consciousness.

Carbon monoxide poisoning can cause permanent brain damage, damage to one’s heart, fetal death or miscarriage, and death. If you or someone you are with are experiencing any of the aforementioned symptoms, it is important to get into fresh air and call for emergency

medical care immediately.

Cold temperatures like the ones Harrison County experienced recently make firefighting and rescue much more difficult. Because of that, vehicle accidents, cold exposure injuries, icy conditions and damage to equipment are all major concerns.

“Firefighting uses water, and with last week’s temperatures, it can freeze within minutes,” Wohlers said. “This can freeze hoses, pumps and nozzles with a quick potential for thousands of dollars in damage, let alone the

‘ice skating rink’ that gets created around a fire scene. The ice also builds on our gear, and at times have made firefighters look like icicles to the point where they can’t move and have to thaw the gear.”

Wohlers noted that firefighters love what they do, but in the winter months it’s a tough love.

“Folks need to take precautions for fire safety, as well as slow down and pay attention when approaching an accident scene and keep us all safe,” he said.



# Dressing for the occasion

Winter weather has arrived across the nation with extreme cold temperatures being recorded in the Midwest. In some areas wind chills have down to -30 to -50 degrees have been reported. With extreme cold weather such as this it is important to be prepared and dress for the occasion.

According to the National Weather Service when weather is chilly, measuring at around 50-60 degrees, it is recommended to have one to two layers on the torso. Each of these layers should be long sleeved. Long pants along with warm socks and shoes should also be worn. A water-proof outer layer should also be worn outdoors to protect from wind chill and rain.

When temperatures begin

to get cold, measuring at 30 to 40 degrees, more layers should be worn. With two to three long sleeve layers on the upper half of the body and one or two layers of long pants on the lower half of the body. Again, warm socks, shoes, and a water-resistant outer layer should be worn with these temperatures.

In cases of extreme cold temperatures that measure lower than 30 degrees, more precautions need to be taken to keep you and your loved ones safe. It is recommended to have three or more layers of long-sleeved clothing on with one being a water resistant and insulated outer layer if you will be outdoors. Two or more layers of long pants should be worn with the outer layer being water resistant if you are planning on

spending a large amount of time outdoors. Again, warm socks and shoes should be worn as well.

With cold and extreme cold temperatures it is wise to have on a hat that covers your ears, gloves and possibly a face shield to protect your extremities as these are the most likely to be harmed at these temperatures. Be sure as well that all clothing fits well. Clothing that is too small can restrict blood flow and make a person feel colder. On the other hand, clothing that is too large can let in cool air also making it challenging to stay warm. Another idea to be sure you are dressed warmly for cold weather is to have an extra bag of warm clothing with you in case you become wet or find that you need more layers to stay warm.

# Temporary closure at DeSoto National Wildlife Refuge for managed deer hunt

DeSoto National Wildlife Refuge will have an antlerless muzzleloader deer hunt on the weekend of Jan. 7-8, 2023. During the hunt weekend, all refuge roads and nature trails will be closed beyond the visitor center to ensure public safety and facilitate a white-tailed deer hunt. The visitor center will remain accessible and open from 8:30 a.m. to 4:30 p.m. To accommodate visitors, the visitor center hours will be expanded to include Sunday from 8:30 a.m. to 4:30 p.m. If Iowa or Nebraska hunters are interested in participating in the managed hunt, contact Peter Rea at 712-388-4803 or [peter\\_rea@fws.gov](mailto:peter_rea@fws.gov).

The refuge facilitates these hunts in cooperation with the Iowa Department of Natural Resources and the Nebraska Game and Parks Commission. Hunting is used as a management tool to control the number of deer on the Refuge.

Hunting is one of six wildlife-dependent recreational uses on refuges which also include wildlife observation, wildlife photography, fishing, environmental education, and interpretation.

DeSoto and Boyer Chute National Wildlife Refuges are located north of Omaha, Nebraska. DeSoto National Wildlife Refuge is located south of U.S. Highway 30 between Missouri Valley, Iowa and Blair, Nebraska. Boyer Chute National Wildlife Refuge, managed by staff at DeSoto National Wildlife Refuge, is located east of U.S. Highway 75 near Ft. Calhoun, Nebraska. # Board of Supervisors discuss drainage districts

The Harrison County Board of Supervisors held two completion hearings at their weekly meeting Friday morning to discuss the acceptance of the Soldier Valley and Upper Soldier #1 drainage district project completion.

The purpose of these completion hearings was to see if there were any additional claims from property owners who may have been adversely affected by the construction, such as crop damage.

For the Soldier Valley Drainage District project, there was reported crop damage by a nearby property owner. The compensation for this damage will be \$3,621.60, according to a document from Project Engineer Jacob Hagan. There were no additional claims brought up at the meeting for both projects.

The Soldier Valley

project was completed on Sept. 15, and the Upper Soldier #1 project was completed on Aug. 31. Both projects consisted of open ditch repairs.

The final cost for the Soldier Valley project was \$856,509.51, which was lower than the engineer's original estimate of \$996,600. This project was done by Midwest Mechanical Industrial Services, which is based out of Logan.

The final cost for the Upper Soldier Valley #1 project was done by Pruetz Grading, LLC and cost a total of \$517,301.06. This amount is higher than the original estimate of \$447,466. According to the document from Hagan, this increase in cost was due mostly to a delay in DNR permitting that led to increased handling costs of rocks needed for the project.

The board of supervisors unanimously approved the results of both completion hearings.

# Lessons from the Holocaust Presentation by Brad Wilkening at the Missouri Valley Library

On Wednesday, Jan. 11, at 6 p.m., in the Missouri Valley Public Library, Brad Wilkening will present a program about the Holocaust and its survivors.

Wilkening has given the program in public libraries and public-school systems to serve as an educational and life-changing event. Its focus is on decision-making as part of our daily lives and the effects it has on other people.

A brief outline of the presentation begins with an historical background of Adolph Hitler and the Nazi rise to power, followed by stories of survivors of prison camps, and then a brief video of a rescuer and the person he was responsible for saving.

Brad's focus is for us to learn from the past so that we avoid making decisions that lead to devastating consequences. It is a message of

hope amidst tragedy and of what individuals can do in trying times to make a difference.

Wilkening is originally from Nevada, Iowa, and has a background in high school education and coaching. He became interested in the events of the Holocaust and attended a class at the Illinois Holocaust Museum. Afterwards, he was chosen to attend a week-long class at Columbia University cover-

ing the subject. As a result of these two experiences, Brad was selected to participate in a class in Newark, New Jersey, sponsored by the Jewish Foundation for the Righteous.

Presently, Wilkening serves as a member of the Iowa Commission on Holocaust Education; this program is his endeavor to fulfill this purpose.

In a world where social media negatively influences

our daily lives, people shoot people at public schools, and terrorists bomb and slaughter innocent people for some obscure reason that is loosely based on faith, Brad's message is an important step for people to learn to take positive action during these trying times.

Please join us downstairs in the Community Room for this program. It is free to the public.

## Extension offers farm business management courses in 2023

Annie's Project and Annie's-inspired farm business management courses will be offered in several locations across the state this winter. The Women in Ag Program at Iowa State University, part of Iowa State University Extension and Outreach, is offering nine Annie's Project courses beginning Jan. 10, and five other Annie's-inspired courses beginning Jan. 4. Courses are three to six sessions long, and include a \$75 registration fee, which covers meals and learning materials.

Annie's Project is offered in Ames, Atlantic, Creston, Edgewood, Fort Dodge, Harlan, Ottumwa, Toledo and Washington. Course participants will learn effective decision-making strategies in five key management areas, including financial, human resources, legal, marketing and production. To learn more about the courses and to register, visit [www.extension.iastate.edu/womeninag](http://www.extension.iastate.edu/womeninag).

**Advanced Grain Marketing** will be offered in Red Oak. Understanding price risk management can help women improve the financial conditions of their grain or livestock farms. Women will learn terminology and the differences between a hedge and an option. A grain marketing simulation tool will give participants realistic practice with options. This course was designed with interactive, fun and hands-on learning opportunities.

**Women Managing Farm Finances** will be offered in Cherokee. Course participants will discover their attitudes toward money and compare farm record keeping systems. Women will explore the concepts of managerial accounting and practice using financial statements to analyze the farm business. Women Managing Farm Finances will incorporate interactive learning with case studies, quizzes and activities while allowing time for discussion and questions.

**Women Managing Farmland** will be offered in Charles City and Oskaloosa. This is a new

multi-session course for 2023 and gives women the knowledge and confidence to improve farmland leasing and access practices, adopt new conservation systems and design more efficient land transitions to next generation farmers. Women will gain insights on how to improve communication with family members, partners and tenants.

**Women Managing Crops** will be offered in Newton. This course is designed for women of all ages and experience levels who want to know more about the key financial and agronomic decisions for corn and soybean production. The sessions take a seasonal approach and cover decision making for pre-planting, growing and harvest.

Annie's Project is a national program reaching 38 states. The mission of Annie's Project is to empower women in agriculture to be successful through education, networks and resources. Annie's Project will celebrate 20 years of inspiring women in agriculture in 2023. The Annie for whom the program is named would have been 100 years old this month. The program was developed to help women like Annie achieve their agricultural goals.

In Iowa, 2,137 women have benefited from 124 Annie's Project courses and 1,317 women have benefited from 97 Annie's Inspired courses. Annie's Inspired courses grew out of the requests for additional information from women participating in Annie's Project. The extension farm management team, county extension professionals and others in the state work together to host local multi-session programs focused on agricultural risk management.

Farm Credit Services of America and USDA are major sponsors for these programs, which reduces the cost for all participants.  December 28, 2022

The special meeting of the Modale City Council was held on December 28, 2022. Mayor James Cox called the meeting to order at 7:00 p.m. Councilmembers present were Blair Adams, Terigen Tiffey, Kathy Dugdale and Katie Offenbacher via Zoom and cell. Amber Larsen was absent. Visitors present were Carl and Linda Anderson, Johnny & Tammy Cooperrider, Robin Mahoney, Jordyn Jenkins, Jay Gerke, April Brewster, Troy from Sundquist Engineering, Dustin Wallis from Armodus, LLC John Glennie, and Elissa Kappes.

Staff present was Shauna Gerke Adams made a motion to approve the consent Agenda. Tiffey seconded; motion carried with a 4-0 vote.

Troy from Sundquist reported on the Sewer bid opening. There were two bids received. The one from Neuvirth Construction was considered as non-responsive by the attorneys at Dorsey, because not all required documents were submitted. The bid from Armodus, LLC had all the required documents, however the bid security was not in a separate envelope as requested. After a conference call with the attorneys at Dorsey, it was suggested the sealed document requirement be waived by the Council as the failure did not give the bidder an unfair advantage. The City did receive an email from Jessica from RD - USDA stating that if either of the bids were approved as is, the City would require extra funding. Troy spoke with Dustin from Armodus who said that some change orders could be made to the bid that could bring the price down a bit. The bids will need to be reviewed by the City's attorney, and the USDA needs to sign off once they receive the letter of recommendation from Sundquist, which has not been made at this time. Cox was concerned about bid rigging and requested that, if Armodus is granted the bid, they do not use Neuvirth as a subcontractor. Dustin reported he had no plan to use them. A motion was made by Tiffey to adjourn the action to award the contract until the January 9th meeting. Dugdale seconded the motion; motion carried with a 4-0 vote.

Citizen inquiries: April Brewster asked how the sewer project was going to be funded. That will be by a grant and must be completed by October, 2023; a loan will cover the rest of the cost. She then asked how much the water bills

would go up, and Cox indicated it would be a negligible amount, but would get the actual figure from Troy.

Tiffey reported that the animal control ordinance currently reads as one horse is allowed on two full acres and must be at least 100' from a dwelling. The current ordinance does not specifically address any other animals such as cows, chickens, goats, etc, other than to say if an animal is deemed a nuisance, it can be addressed through the current ordinances. A lengthy discussion was had regarding current animal placement and if they conform to the current ordinances. Offenbacher requested rewriting of the ordinance be tabled until all the ordinances can be reviewed and amended, if necessary. The other Council members agreed, and it was decided that until the ordinances are rewritten, the City will act on any written and signed complaint via the current ordinance. If a nuisance complaint is made, it needs to be in writing and sent to Mayor James Cox. At that time a review of the situation will be made. If it is determined the ordinance is not being followed, a letter of abatement will be sent. At that time the person or persons violating the ordinance will have a chance to plead their case to the City Council. If the Council decides it is a nuisance, then the issue will be referred to the City's attorney for further consideration. Any current complaints that are not in writing will not move forward. If anyone receives a complaint, it must be in writing (text messages do not conform to this requirement) and forwarded to the Mayor for follow-up.

A discussion about what type of tree(s) we were requesting, where the tree(s) would be placed and the amount to be requested was had. It was decided to move forward with the application, however no motion was made regarding the portion of the funds the city would have to match. No action was taken on this item this year.

Dugdale made a motion to adjourn. Tiffey seconded the motion; motion carried with a 4-0 vote. Mayor Cox adjourned the meeting at 8:20 p.m. James Cox, Mayor Shauna Gerke, Deputy City Clerk These minutes are as recorded by the City Clerk and are subject to Council approval at the next regular meeting. ## Wallis takes chance, signs with Morningside

Logan-Magnolia senior Calvin Wallis knew up front the three things he wanted when making his post-high school announcement.

First, he wanted it to be close to home where family and friends could come watch him play; Second, the coach and team had to have a family type atmosphere; and finally, the coaching staff did an excellent job of staying contact with him the last two seasons.

All three criteria was met when Wallis committed to Morningside College (Sioux City) right before the holiday break.

"They (Morningside) did an excellent job of staying in contact with me the last two seasons," stated Wallis, who was also considering signing with Wartburg (Waverly, Iowa). "It was a huge family like atmosphere, and they are known for being a perennial power at the NAIA level. The culture that surrounds that program is unbelievable, and I can't wait to be a part of it."

Morningside has won the NAIA National Title three of the last five years.

"The student-faculty relationship helped sway my decision," Wallis stated. "Early in the recruiting process, they were one of my top choices. I've always dreamed of playing at the next level, and now I have my chance."

Wallis hopes to find a spot in the defensive backfield, unsure of weather cornerback or safety, Wallis concluded. He knows if he has a chance to make a big play, he'll be on attack mode.

Wallis had 50 tackles his senior season, picking up two fumble recoveries and adding four interceptions. The Panther finished with 14 career interceptions (4-sr.; 8-jr.; 2-soph.), as well as being selected as a two-time All-District player and a two-time Iowa Sports Writers Association All-State Player.

"I just have a knack for being around the ball and making plays," Wallis concluded. "Being part of a National Championship team would be amazing. I definitely think its within reach over the next couple of seasons."

Wallis is the son of Kandi and Eric Wallis of Logan.

# The Lost Preparation Table

What the heck is a Preparation Table? Why? Getting ready for a celebration? Lost? Where is it?

It is an environmental sculpture created by Gina Crandel, Professor Dept. of Landscape Architecture, College of Design, Iowa State University. She was on site to oversee and participate in the erection of the art work. It was a part of the "Land of the Fragile Giants: Landscapes, Environments, and Peoples of the Loess Hills" art exhibit being celebrated at Moorhead in 1994.

The plan was to plant many tall poles in the ground along and down the slope of the hill. They were to be aligned every 15 feet in a formation of straight lines in four directions, so that no matter which way you looked they lined up. The tops of them were level with each other. The sculpture demonstrated how steep the hillside was at different elevations as the poles stuck from the ground in different measurements. Also, since the Hills were thought to be so fragile, it was to demonstrate how much and how quickly the slope fell away, leaving more of each pole exposed with each passing year.

It is interesting to remember, that Iowa State

University sent land surveyors out to mark a grid to where each pole was to be set. Farmers and friends brought their hand held post-hole-diggers, dirt packers, a level and shovels and began digging to set the poles. But, they soon noticed that the markers for the holes did not line up with the plan! Wilbur Mann, Don Solberg, Larry and Georgine Wessell, Ryan Miller, Robert Shol, Jerry and Ruth Pickle, Darrell Wessell and John and Lynette Pohlman were among the diggers that knew how to layout a straight fence line and align corner posts in the Hills, so they created a new grid! Mira Crandel, Professor of the Department of Landscape Architecture, College of Design, Iowa State University was on hand doing what needed to be done, also. An Iowa Public Television crew

was on site to document the important event.

Lynette Pohlman, curator of the I.S.U. Brunner Museum at Ames and daughter of Darrell and Lorna Perrin Wessell, while moving soil, was educating all of us about the significance of what we were doing. Pohlman seemed to wonder out loud, "what should the sculpture be named?" Many appropriate thoughts and suggestions came from the utterances of the group. One, quiet seemingly unrelated to the Hills idea was 'Preparation Table', "because the tops of the poles would support a level table top and if the hill slope eroded away the table would topple! Plus it was located at Preparation State Park", it was explained. Several weeks later it was learned the 'Preparation Table' suggestion had been selected as it announced the location

and was culturally and environmentally significant.

Having completed the task of setting the poles, the group retired to the Bluebonnet Cafe in Moorhead for refreshments. One of the men laughing, commented, "I thought we were going to help with art, but instead, we dug holes!" A photograph of the environmental art work traveled with the exhibition as it toured many sites across Iowa, the world and returned to be exhibited in our nation's rotunda.

Recently, I revisited the site and took the short hike down the ridge to the 29 year old

lost sculpture. After all these years the sculpture is unsigned. I followed a very narrow unmarked hidden path that commenced near the corner of the Old Harry Rice Skating Rink fireplace. The fire place is just inside the upper park gate. The concealed path leads down the razor back of the hill to the lost 'Table'. Hiking along this summer only trail, all of a sudden the poles appeared! The 20 markers were still in place and the soil erosion appeared to be minimal! Which substantiates a comment in the Des Moines Register of December 1, 1999, "Cut this fine, pure soil

at an angle and the rain will destroy it. Cut it straight and it will stand almost forever."

I have been back only a few times to review the changes in the slopes on each side and the point. The time I remember most is when, my 8 year old granddaughter, Alison Pickle, accompanied me. We were walking along the narrow worn path edged with Big Bluestem grass, which was well over my head in height. Alison, was leading the way and stopped, turned around and looked up at me and said, "It makes you feel so insignificant, Grandma." Out of the mouths of babes.

## What to consider before plugging in a space heater

Small space heaters are typically used when the main heating system is unavailable, inadequate, or when central heating is too costly to install or operate. In some cases, small space heaters can be less expensive to use if you only want to heat one room or supplement inadequate heating in one room. They can also boost the temperature of rooms used by individuals who are sensitive to cold without overheating your entire home.

Small space heaters work by convection (the circulation of air in a room) or radiant heating. Radiant heaters emit infrared radiation that directly heats objects and people within their line of sight, and are a more efficient choice when you will be in a room for only a few hours and can stay within the line of sight of the heater. They can also be more efficient when you will be using a room for a short period because they save energy by directly heating the occupant of the room and the occupant's immediate surroundings rather than the whole room.

Safety is a top consideration when using small space heaters. The U.S. Consumer Product Safety Commission estimates that more than 1,700 residential fires every year are associated with the use of space heaters, resulting in more than 80 deaths and 160 injuries nationally.

Space heater capacities generally range between 10,000 Btu and 40,000 Btu per hour, and commonly run on electricity, propane, natural gas, and kerosene (see wood and pellet heating for information on wood and pellet stoves).

When buying and

installing a small space heater, follow these guidelines:

- Newer model small space heaters have current safety features. Make sure the heater carries the Underwriter's Laboratory (UL) label.
- Choose a thermostatically controlled heater, because they avoid the energy waste of overheating a room.
- Select a heater of the proper size for the room you wish to heat. Do not purchase oversized heaters. Most heaters come with a general sizing table.
- Locate the heater on a level surface away from foot traffic. Be especially careful to keep children and pets away from the heater.

**Vented and Unvented Combustion Small Space Heaters**

Small space heaters are classified as vented and unvented or "vent-free." Unvented combustion small space heaters are not recommended for use inside your home because of the risk of carbon monoxide poisoning. They may also bring unwanted nitrogen oxide into the home; nitrogen oxide can cause asthma and other respiratory problems. These heaters can also introduce water vapor into the home, which can result in mold and other structural damage. Most states have banned unvented kerosene heaters for use in the home. California, and some other cities and counties, have banned the use of unvented natural gas heaters in the home.

Vented, small space portable heaters are designed to be located next

to an outside wall, so that the flue gas vent can be installed through a ceiling or directly through the wall to the outside. Look for sealed combustion or "100% outdoor air" units, which have a duct to bring outside into the combustion chamber. Sealed combustion heaters are much safer to operate than other types of space heaters, and operate more efficiently because they do not draw in the heated air from the room and exhaust it to the outdoors. They are also less likely to backdraft and adversely affect indoor air quality.

Less expensive (and less efficient) units use the room air for combustion. They do not have a sealed glass front to keep room air away from the heating elements and should not be confused with a sealed combustion heater.

In addition to the manufacturer's installation and operating instructions, you should follow these general safety guidelines for operating any combustion space heater:

- Never use gasoline! For liquid-fueled heaters, use only the approved fuel. Follow the manufacturer's fueling instructions. Never fill a heater that is still hot. Do not overfill the heater -- you must allow for the expansion of the liquid. Only use approved containers clearly marked for that particular fuel, and store them outdoors.
- Have vented space heaters professionally inspected every year. Improperly vented (and unvented), blocked, separated, rusted, or corroded small space heaters may emit dangerous levels of carbon monoxide (CO) and

other gases into the home, causing sickness and death. Carbon monoxide can also be produced if the heater is not properly set up and adjusted for the type of gas used and the altitude at which it is installed.

- Install a carbon monoxide detector if you use a small space heater.

### Electric Small Space Heaters

Electric small space heaters can be more expensive to operate than combustion space heaters. Although they avoid indoor air quality problems, electric small space heaters still pose burn and fire hazards and should be used with caution.

For convection (non-radiant) space heaters, the best types incorporate a heat transfer liquid, such as oil, that is heated by the electric element. The heat transfer fluid provides some heat storage, allowing the heater to cycle less and to provide a more constant heat source.

When buying and installing an electric small space heater, you should follow these general safety guidelines:

- Electric heaters should be plugged directly into the wall outlet. If an extension cord is necessary, use the shortest possible heavy-duty cord of 14-gauge wire or larger. Always check and follow any manufacturer's instructions pertaining to the use of extension cords.
- Buy a unit with a tip-over safety switch, which automatically shuts off the heater if the unit is tipped over.

## Stay safe on the ice this winter

With cold weather finally arriving in Iowa and freezing over lakes and ponds, ice fishing activity has begun at certain northern lakes. As a note of caution, the Iowa Department of Natural Resource (DNR) reminds all anglers - especially those in central and southern Iowa - to stay patient and allow that ice thickness to grow before heading to their favorite ice fishing spot.

The DNR recommends a minimum of four inches of quality ice for fishing and at least five inches for snowmobiles and ATVs.

Ice forms at different rates on each body of water depending upon its size and depth. Once frozen, conditions change constantly and ice thickness can vary across the lake. Rocks, trees, docks or other things that poke through the ice will conduct heat and make the ice around it less stable. The DNR recommends that anglers test the ice thickness frequently and to trust your instincts - if the ice does not look right, don't go out.

A blanket of snow on top of an ice covered lake insulates the ice, slowing the growth of ice and hiding potential hazards or weak spots. River ice is 15 percent weaker than lake ice. Ice with a bluish color is safer than clear ice. Avoid slushy or honey-combed and stay away from dark spots on the ice. Don't walk into areas where the snow cover looks discolored.

### Safety Tips on the Ice

- No ice is 100 percent safe.
- New ice is usually stronger than old ice.
- Don't go out alone - if the worst should happen, someone will be there to call for help or to help rescue.
- Let someone know where you are going and when you will return.
- Check ice thickness as you go out - there could be pockets of thin ice or places where ice recently formed.
- Avoid off-colored snow or ice. It is usually a sign of weakness.
- The insulating effect of snow slows down the freezing process.
- Bring along these basic items to help keep you safe: hand warmers, ice cleats to help prevent falls, ice picks (wear around your neck) to help you crawl out of the water if you fall in, a life jacket, a floating safety rope, a whistle to call for help, a basic first aid kit and extra dry clothes including a pair of gloves.
