Work starting on Lo-Ma dome project

Construction is set to begin on Logan-Magnolia's long awaited dome and new commons area within the next couple of weeks, according to school board President Brian Koenig.

Genesis Contracting Group is the district's contractor. It built a similar dome in Central City, Neb., a few years ago. The district's architect is Incite Design Studio, which also has experience with dome designs.

"As part of that construction, the existing building will be connected to a new commons area that will bridge the existing building to the top-load dome that will extend south toward the football field," a release from the school states.

The dome will contain a two-lane track at the top of the bleachers, will fit up to three wrestling mats, two 84-foot basketball courts and two regulation-size volleyball courts, all while providing better seating for those cheering on the


Panthers or visiting. The total estimated cost of the dome project is \$10.3 million, Superintendent Tom Ridder shared Monday morning.

Drawing more interest from visiting teams will also be part of the added benefit to the community, Koenig said.

"(The dome) also will allow the school to host district and substate events that the district previously could not host," Koenig said in an email to the Times-News. "... The completion of this space will allow us to host many more events than we could previously and for our students to have home junior varsity matches and better practice schedules."

The school district is also exploring avenues for a grant that would provide public access to the dome's track and existing weight room during certain hours outside of school activities.

Furthermore, the dome will serve as a safe space for students and staff in the case of a

severe weather event.

On top of what the dome itself will provide for the district, there are other pertinent parts of the project in play as well.

Industrial Drive, which runs behind the school, will also be connected to the circle drive behind the school with a new access road that will replace the current one where the new commons area will be constructed.

The district hopes to keep as many trees currently on the site as possible. "In addition, the

"In addition, the

district plans to engage a local architect to begin evaluating an additional option for the classroom portion of the project by modifying the north half of the existing metal building located just east of the elementary into our pre-kindergarten facility that the district purchased last year," Koenig said.

According to Koenig, this option would help free up at least three classrooms in the existing elementary, which would help the district alleviate traffic congestion during pick-up and drop-off times and pro-

vide space the district needs for the project in a more "cost-efficient manner."

The goal is for the prekindergarten facility, as well as science classroom improvements, to be completed prior to the start of the 2025-26 school year, Koenig said.

Anticipated completion of the dome and commons is the fall of 2025.

Dry, windy weather play role in two recent fires

The Missouri Valley Fire Department responded to one collision and two fires over the course of the past week as of Monday morning, with elevated fire weather conditions playing a role.

On Feb. 28 at 7 p.m., the department was called to a three-vehicle accident on Highway 30 near the Cavalry Falls Event Center. With the Logan Fire Depart-

ment also assisting on the call, the MVFD's rescue truck set up a landing zone while the ambulance dealt with a minivan rescue situation. A mother and her three children were safely triaged by on-site personnel after exiting the vehicle, according to a statement from the department. They were transported to CHI-Missouri Valley with minor injuries.

The Harrison County Sheriff's Office is currently investigating the crash, and the department is unaware of the conditions of anyone else involved in the accident.

Last Thursday at 3 p.m., the department received a page for mutual aid to Little Sioux for a multi-structure fire. One engine and one tanker were dispatched northbound to the location, and crews remained at the scene until 8 p.m.

"Unfortunately, all structures at the site were a total loss due to reports of an unattended campfire that sparked the blaze," MVFD said in a statement. MVFD said nine area fire departments were said to have responded to the event.

On Sunday at 3 p.m., the department was paged to a field fire behind the Wisecup Museum near Missouri Valley. Modale was also called to the scene.

With wind and smoke obscuring the true size of the fire, Mondamin and Crescent crews were also requested at the site. The request was canceled after reassessing the scene as crews worked on the fire, MVFD said.

"Modale and our crews handled the bulk of the fire with assistance of two tractors with disks," the department shared. "These made a huge difference in keeping the fire from spreading more quickly and were greatly appreciated."

MVFD estimated that 5 to 6 acres burned, and said that the fire was caused by two fuses that blew on a nearby power pole.

Getting on the scene just 12 minutes after the call, the fire had already spread over nearly 4 acres.

"That's how dry it is and how the wind can push a fire," MVFD said. "If the fire would have made it to Willow Creek that would have been very detrimental. Examples like this these are why we are asking for no burning until we get moisture."

The Sparkplugs safety club composed of Missouri Valley High School students conducted a week long traffic survey from February 22 - 28.

The survey was conducted to determine how many motorists are violating the laws. Its results are very interesting.

Stop sign checks were made at Sixth and Huron Streets, Sixth and Erie Streets and Fourth and Huron. The survey showed that 207 vehicles or 44 percent came to a complete stop. 205 or 43 percent rolled through and 53 or 11 percent did not stop. Speed checks were conducted on 282 cars in a 25 mile per hour zone on West Erie Street. 199 (or 70 percent) were exceeding the speed limit; 63 (or 22 perecent) were exceeding the limit by 10 miles per hour; and 20 (or 8 percent) were at or below the speed limit.

The metal cream cans must have been in the mix. Possibly, during the three-cow dairy operation, there was extra cream and the folks hauled it in the cans to De Smet, though we don't know where. After the Depression and WWII, times were still hard. Likely, income from selling cream and other produce helped farmers stay afloat. Deloris helped churn butter in the small wooden churn as it sat on the kitchen table. Dad loved buttermilk, the byproduct of butter making. Mom also used it for baking. Of course, any extra went to the slop bucket, which made the hogs happy. Around that time margarine became very popular. We called it oleo. (Another story?) Though we still enjoyed homemade butter, it gradually separated

Mom skimmed the cream off the jars of milk once they sat in the refrigerator for a day. All of us remember enjoying the cream of the crop! Creamy gravy on mashed potatoes. Scalloped potatoes, scalloped cabbage, scalloped corn were all made with heavy cream. Peas, beans, carrots and pretty much every vegetable we raised was served, swimming in whiteness. Dad always said the vitamins were in the juice; add milk or cream and vitamins never tasted so good!

Secretary Naig leads trade mission to Mexico

DES MOINES - Iowa Secretary of Agriculture Mike Naig and a delegation of farmers and other agricultural industry leaders recently returned from a trade mission to Mexico that was held Feb. 18-24. Iowa companies exported \$4.2 billion in goods to Mexico in 2023, a new record for Iowa exports to Mexico. Mexico is Iowa's largest export destination for corn, pork, distillers grains, a byproduct of ethanol production, and second for soybeans.

Financial highlights The District's revenues totaled \$6.306.011 for the year ended June 30, 2022, a 9.39% increase over the prior year. The District's expenses for the year ended June 30, 2022 totaled \$5,780,047, a 6.01 % decrease from the prior year. Revenues increased due to an in-

crease in unrestricted state grants and operating grants, contributions and restricted interest. The decrease in expenses occurred primarily in the instruction function. Audit findings

Nolte, Cornman & Johnson P.C. reported six findings found on pages 67-71 of this report. The findings address issues such as a lack of segregation of duties, questionable disbursements, board minutes, supplementary

weighting, student activity fund and financial condition. Nolte, Cornman & Johnson P.C. provided the District with recommendations to address each of the findings.

Five of the six findings discussed above which relate to the District are repeated from the prior year. The Community School District's Board of Education has a fiduciary responsibility to provide oversight of the Community School District's operations and financial transactions. Oversight is typically defined as the "watchful and responsible care" a governing body exercises in its fiduciary capacity.



reference to it being outside of the workplace. It

hind a desk, yet millions of people experience it on a daily basis and it's written off.

Sexual harassment by definition is the use of explicit or implicit sexual overtones, including the unwelcome and inappropriate promises of rewards in exchange for sexual favors.

There are no direct references to the workplace in this definition. So, why are we ignoring that it takes place just about anywhere you step foot? It can happen in the grocery store, a restaurant and even on the walk to your front door.

As a 23 year old, there is one location that

truly grinds my gears nightlife. As a society, we have merely written off the idea of sexual harassment in a bar or club. It's almost as if it's to be expected when you walk into a place that solely serves alcohol.

In a 2018 parliament report, it was stated that, "It is a cultural norm, and women are no longer surprised to be hassled, harassed or assaulted (in nightlife locations)."

I can attest to the culture of laughing off a cat call or offensive comments toward my body. I am a woman after all, which apparently means my body is an open forum to the public.

We are expected to brush it off, because at the end of the day, there are no enforcements focused around the belittling of women. Even in the workplace — where it is most commonly referenced — there's no overarching law.

Sexual harassment in the workplace isn't prohibited by law until it becomes frequent or severe or when it results in the employee being fired for their actions, according to the US

Equal Employment Opportunity Commission.

Women are not the only ones subjected to this defilement, though, -- many men experience the same grotesque comments. One in nine men have experienced some form of sexual harassment in a public setting, according to Centers for Disease Control and Prevention.

We live in an age where these comments are just part of our daily routine. Before people go out in any public place, they merely have to prepare themselves for the possible comments they may receive. Though it may seem outrageous, it's severely common.

Women and men shouldn't have to become acclimated to being sexually harassed. There's no rational reasoning to these actions. Just because it doesn't rise to the levels of severity outside of the workplace, doesn't mean it should be culturally accepted in public places.

Eligible customers may qualify for Lifeline discounts of \$5.25/month for voice or bundled voice service or \$9.25/month for qualifying broadband or broadband bundles. Residents who live on federally recognized Tribal Lands may qualify for additional Tribal benefits if they participate in certain additional federal eligibility programs. The Lifeline discount is available for only one telephone or qualifying broadband service per household, which can be either a wireline or wireless service. Broadband speeds must be at least 25 Mbps download and 3 Mbps upload to qualify.

A household is defined as any individual or group of individuals who live together at the same address and share income and expenses. Services are not transferable, and only eligible consumers may enroll in these programs. Consumers who willfully make false statements to obtain these discounts can be punished by fine or imprisonment and can be barred from these programs.
