decided to attempt the recordbreaking flight is because he believes it can be done.

"The brainchild of trying to land in 48 states in 48 hours was actually another pilot's, who attempted the feat in 2021, but failed. When I heard about this, I wondered if this was actually feasible? So, I break out a flight planning app and start creating routes, and was like, damn, this can be done. After learning that it's not mission impossible, I was like, OK, let's do this, so, I started planning and created the nonprofit, 48N48, which morphed into promoting aviation for future pilots.

Additionally, any proceeds from funds raised through 48N48 will benefit Veterans Airlift Command, which gives veterans and their families free flights for medical care," explained Behnfeldt.

There will also be another pilot to assist in flying the plane over the course of two days.

"My co-pilot is Aaron Wilson. He is an Air Force veteran and he also has experience flying Saratoga planes, so it was easy to get him insured," Behnfeldt said with a chuckle.

The current world record for flying and stopping in all 48 contiguous states is 16 days, while the National Aeronautic Association record is slightly over four days.

"I am confident that we can do it in half the time of the current National Aeronautic Association record as long as the airplane keeps on chugging," Behnfeldt confidently stated.

He also ensured that he and co-pilot Wilson will get adequate rest during the trip.

"There are two pilots and one will be resting while the other one flies. In fact, I got permission from the FAA to remove two seats from the plane and build a platform for a mattress so everyone on the flight can get sleep when needed," Behnfeldt noted.

These would be much more environmentally friendly.

It is time to clean out those birdbaths that have been sitting out in the winter weather. Mine was full of mold, so I used bleach to clean it up. I followed that up with a 1/4 cup sugar and a sponge to scrub it clean. Rinsed it with water until it was clear. The sugar is a good scrub, environmentally friendly, and neutralizes the chlorine.
