Local dentist pleads guilty, begins serving sentence

Savannah dentist Stacy Wilkerson began serving a 10-day jail sentence last week after pleading guilty to three charges from an April 23,2022 driving under the influence incident.

Wilkerson, 53, pleaded guilty to DUI first offense, reckless endangerment and leaving the scene of an accident, according to court documents filed March 6.

The documents say Wilkerson was facing a maximum of three years in jail and fines totaling \$6,500, with each of the three counts allowing a maximum sentence of 11 months and 29 days.

The court documents say Wilkerson's sentences for the three counts are to run consecutively, and he is to serve 10 days in jail on consecutive weekends, with the balance of the three years suspended.

Wilkerson will be on supervised county probation for the term of his suspended sentence, and must pay a total of \$1,550 in fines, according to court records, and his driver's license is suspended for one year.

The court documents add that Wilkerson must remain compliant with a Tennessee Dental Wellness Foundation contract he entered into on May 5, 2022, as a condition of his probation. He is also required to submit random drug and alcohol tests upon request from his probation officer, at his expense.

According to the foundation's website, its mission is to "help restore lives to a life worth living, save careers, and thereby serve the citizens of Tennessee."




