The permit application, supporting documentation including detailed plans and maps, and related comments are available at the Division's address (listed above) for review and/or copying or by visiting the TDEC website at https://www.tn.gov/environment/topic/ ppo-water and searching on the Application Number listed below. Interested persons may also request in writing that the Division hold a public hearing on this application. The request must be filed within the comment period, indicate the interest of the person requesting it, the reason(s) that the hearing is warranted, and the water quality issues being raised. When there is sufficient public interest in water quality issues, the Division shall hold a public hearing in accordance with 0400-40-07-.04(4)(f). In deciding whether to issue or deny a permit, the Division will consider all comments of record and the requirements of applicable federal and state laws. In making this decision, a determination will be made regarding the lost value of the resource compared to the value of any proposed mitigation. The Division shall consider practicable alternatives to the alteration, loss of waters or habitat, diminishment in biological diversity, cumulative or secondary impacts to the water resource, and adverse impacts to unique, high quality, or impaired waters.

PROJECT DESCRIPTION / PURPOSE

The applicant proposes to restore over 50,000 feet of White Oak Creek and its tributaries. An additional 15,720 linear feet will be incorporated into the currently channelized streams, optimizing sediment transport, improving debris processing, increasing stability and reconnecting stream and wetland habitats to base flows. POINTS OF IMPACT

STREAM 1: Latitude: 35.341115 Longitude: -88.266269

White Oak Creek

The current 23,930 linear foot canal will be replaced by 33,100 linear feet of constructed meandering stream channel. The existing scrub and open water wetland will likely convert to a forested wetland in the upper reaches of the stream. The middle stream reach will likely trend towards being seasonally flooded while the lower reach will persist as shrub and open water wetland.

STREAM 3: Latitude: 35.352786 Longitude: -88.32393

The current 4,400 linear foot canal will be replaced by 6,100 linear feet of constructed meandering stream channel. The existing shrub wetland consisting of dying timber and beaver modification will likely convert to a seasonally flooded forested wetland.

STREAM 4: Latitude: 35.350265 Longitude: -88.296808

Hurricane Creek

The current 10,800 linear foot canal will be restored by the construction of 14,230 linear feet of meandering stream channel. The existing scrub wetland will likely convert to a semi-permanent or seasonally flooded forested wetland. STREAM 5: Latitude: 35.337383 Longitude: -88.261102

6,000 linear feet of the existing canal will abandoned and 2,200 linear feet of the existing stream will be meandered into White Oak Creek to improve competence. The existing scrub wetland will likely convert to a forested wetland.

STREAM 6: Latitude: 35.343125 Longitude: -88.253377 Crooked Creek

The current 980 linear foot canal will be restored by the construction of 2,100 linear feet of meandering stream channel. The fully blocked floodplain will likely convert to a forested wetland.

WATERSHED / WATERBODY DESCRIPTION

The Tennessee Western Valley (Beech River) Watershed is located in Tennessee and Mississippi. The Tennessee portion of the watershed (97.8 percent of the watershed) includes parts of Benton, Carroll, Chester, Decatur Hardin, Henderson, Humphreys, McNairy, Perry and Wayne counties. It drains approximately 2,097 square miles, 2,041 square miles of which are in Tennessee, and empties to the Tennessee Western Valley (KY Lake) Watershed. 
DETERMINATIONS

Fire on board a boat

A person may only have a split second to act to save themselves and all passengers. The importance of having fully charged fire extinguishers on hand is vital.

Most boat fires can be put out rapidly if you act immediately. Do not hesitate. If a fire starts, grab the extinguisher, activate it and direct it at the base of the flames. Use short bursts and sweep it from side to side. Do not wait until a fire starts to read the directions on the label. Take the time to make sure that you and those who boat with you regularly know and understand exactly how to use the fire extinguisher.

There are several preventable measures to take in order to avoid most boat fires:

- · Clean bilges often and maintain proper gear stowage.
- Make sure short-tie cables are properly connected.
- Place oily rags in covered trash cans or dispose of them on shore.
- Store propane fuel for

stoves in a secure area. If and when a fire does break out on board your boat, never use water on fires started electrically, by gasoline, oil, or grease. Water will spread a gasoline fire and since water is a conductor of electricity, you may receive a damaging shock from an electrical fire. Water should only be used to extinguish burning wood, mattresses, rags, rubbish, and alcohol. When extinguishing the fire, make sure it is completely out. If not, it may smolder for a long while and possibly start again. If possible, soak burning materials over the downwind side of the boat.

Also remember to avoid removing any debris after the immediately. emergency is over.

the fire from spreading to other parts of the boat:

- Wind from the boat's motion feeds the flames.
- Keep the fire downwind. If the fire is aft, head the bow into the wind. If forward, put the stern into the wind.

• If the motor catches littering the waterways by fire, shut off the fuel supply

Always remember not to Follow these steps if fire panic.
