Meet Hardin County's new Veterans Service Officer

Nick Stokke is Hardin County's new Veterans Service Officer.

He succeeds C.D. Rickman, who died following a long illness in late September.

"I look forward to working with Nick - he was recommended by C.D. himself, and that's some big shoes to fill," said Jana Shelby, Rickman's administrative assistant for six years, in the office 18 years, and now working with Stokke.

talked to me about, so I know he's gonna do good," Shelby said of Stokke.

Stokke took over the office on Nov. 29, following stints with American Food Service and as a manager at Aaron's Furniture – but it's his military service that most qualifies him for the job, and interested him in applying.

"I owe everything to this position, because I've been in the position to need help from this office. If I can help even one veteran in this office, I'll be grateful, and I will do whatever I can to help every veteran I can," Stokke said, adding, "I owe everything to it."

Stokke said he was in the Army and National Guard for nine years as a combat medic, serving a tour in Iraq and ending his service as a staff sergeant

He played football for Hardin County High School and graduated from there, before attending the University of North Alabama – playing football there as much as he $could-and\,earning\,a\,bachelor's$ degree in business.

Stokke has also been active in civic pursuits here in Hardin County lately, coaching Junior Pro football, where his team "won the championship this year," he said with big grin.

He's also an active member of Veterans of Foreign Wars Savannah Chapter 4606, working on projects with Post Commander Tommy "Motor" Lewis, and former Post Commander Lanny Sartor for several years.

"The night I was sworn in at the VFW was the night they unveiled the plans for the new Savannah Veterans Memorial Park," he recalled.

In office as new county VSO for only a week, Stokke said he's already had to opportunity meet with and help "quite a few" local veterans with available services so far. He's also been

"He's the only one C.D. ever busying himself with several office projects, including further work at the Savannah Veterans Memorial Park, Wreaths Across America, and a field trip he's hoping to organize to a veterans' organization called "WarHorses for Heroes."

WarHorses for Heroes is a non-profit organization that provides equine-assisted therapy to veterans who have sustained service-related mental or physical injuries. Some of the available services are grooming, groundwork, horseback riding, and even advanced horsemanship classes.

According to WFH's website, one in four veterans shows signs of mental illness, and 1 in 10 veterans is physically

WFH creates a safe haven and cohesive environment in which veterans can feel at home and welcome.

"One of the main struggles we hear about is veterans not feeling like they belong or that they 'lost' their family after separating from the military. War-Horses for Heroes strives to introduce them into a new and supportive family that they can utilize to rebuild their lives in the civilian world," the site says.

That, says Stokke says, is what he wants to do as Hardin County's VSO, and why he took the job.

"Please don't make this (story) too much about me, make it about the office," he told a reporter. "In the end, a bunch of stuff about me doesn't really matter - but this office does. This office matters an awful lot."
