Black Tie & Boxing brings in more donations for STAR Center

Black Tie and Boxing has become one of Jackson's favorite fundraisers.

It's big and loud with a Las Vegas feel and the crowd is dressed to the nine's.

The event has grown in leaps and bounds since entering a partnership with The Star Center.

Renovation of the Carl Perkins Civic Center is still underway, so this year's event was moved to the Jackson Fairgrounds.

Star Center President Jennifer Graves said the usual cheers from the balcony were missed but the excitement in the air and the will of the fighters were definitely there.

"Some of them have never done anything like this before so they've been working out three times a week for three months, and some have fought before," Graves said. "These are true amateur fights, fighters who are trying to go pro."

"We have a fight promoter

here, Ryan Collins, who does a great job of bringing in local talent for us. There are also out-of-state fighters here."

The fundraising goal is in the \$250,000 range and donations typically come in the week after the event.

The Star Center also hosts the Flint Cox Golf Tournament in May and Dancing with the Stars in October. Graves says there are other fundraisers in the works that will be announced soon.

The 10 member Black Tie Fight Club is made up of community leaders who advocate for the Star Center.

Since October of 2023, Arrow Athletics has trained club members, some with little or no fight experience. Each member agrees to raise \$2,000. Fight Club Member Keith Busby was recognized for raising the largest amount with a total of \$4,659.75. Fight Club winners were Jessica Vowell-Ross, Keith Busby, Eric Bays, and Will Eason.

Sacred Heart community mourns loss of Andre Bell

As news spread throughout Jackson and Madison County on Monday of this week, people in the Sacred Heart of Jesus High School community and local basketball fans were sad to hear of the passing of Knight alum Andre Bell.

Bell was a part of the final graduating class at Sacred Heart before it closed in 2024.

He'd signed on to play college basketball at Fisk University in Nashville, and he was there in his second year with the school when tragedy struck this past weekend.

According to statements from the City of Nashville Public Affairs Office and Fisk University, Bell and a couple of friends had volunteered to help Sunday afternoon at a Fisk gymnastics event at the Fairgrounds in Nashville.

About 8 p.m. that night, Bell and his friends were on their way back to campus on I-65 North with Bell driving when a dark sedan pulled up beside them and gunfire came from the vehicle and fatally struck Bell.

"Bell's friends reported noticing a dark sedan in the left lane



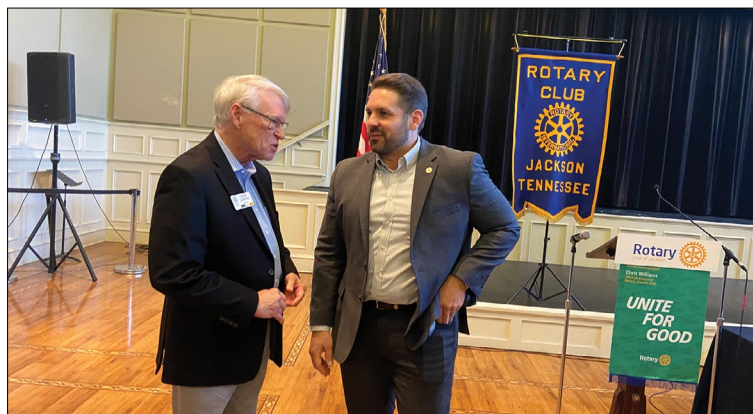

beside them," said the statement from the City of Nashville regarding the police investigation into the shooting. "Both said they were distracted by their cellphones when they suddenly heard multiple gunshots and realized Bell had been hit. The Sentra slowed and spun back into traffic before colliding with a red pickup truck. The dark sedan kept going."

News of Bell's passing became public Monday morning, and those connected with Sacred Heart express sadness of Bell's passing.

"Andre Bell was a member of

Conger celebrates accomplishments with State of the City

Jackson Mayor Scott Conger gave the first edition of his annual State of the City address to the Jackson Rotary Club on Wednesday, Jan. 7, and his speech highlighted the work of the departments of the City of Jackson during 2025.

He first acknowledged how City leadership found itself in familiar territory last year at budget time, having too much expenses left at the end of the revenue.

But he said everyone involved

in the process including the department heads and the workers they manage did their best to continue the work for the citizens while staying within the confines of that budget.

The City's customer service, record keeping and accounting are all a simpler process now because of the work done by the IT department as well as others in the City to modernize and digitize their paperwork and systems.

He praised the work of the Jackson Police Department not

Miller running for County Mayor again

Frencherry Miller is a native of Madison County who served nearly three decades in the United States Marine Corps and came home a few years back with a willingness to serve.

On Thursday, Jan. 8, Miller and about 40 supporters gathered at the DoubleTree Hotel as he formally announced his intention to run for Madison County Mayor.

"I'm from here, and I love my home, and I want to do what I can to help it move forward any way I can," Miller said.

This is Miller's second time to run for the position after having run with the Democratic nomination in 2022. This time he's running as an independent.

"I'm not for one party or another," Miller said. "I'm for everybody, and it doesn't matter to me what your political beliefs are."

"There are some ideas from both sides that I like and others from both sides that I don't, so this is a better way for me."

Miller said leadership is something he's passionate about as he had a number of certifications after various training sessions and periods during his career with

the USMC.

"There were times when I was stationed overseas when I was the highest ranking Marine in the

country and was expected to make decisions that affected our people and the

Memphis' Perkins signs on to run for D-8 U.S. Rep.

Leonard Perkins Sr. spent decades in the United States Air Force in air traffic control.

Since retiring, he's spent nearly 20 years advocating for military members in different roles in the Department of Veterans' Affairs and with private organizations like All Veterans of America and Vietnam Veterans of America.

He's a pastor who worked on staff at a church in Memphis for a year or two before stepping out on his own, restoring a condemned building and planting a church in that he's pastored for 25 years.

"I have a heart for people, for veterans and for all Americans, especially those of us in this part of the country and state," Perkins said.

That's why Perkins is running for the Democratic nomination to challenge United States Congressman David Kustoff for the District 8 position to represent Tennessee in the U.S. House of Representatives.

He worked hard Friday, Jan. 9, to show he's ready to run for the position and serve. "My wife and I got a hotel room in Nashville last night and stayed up there so we could be at the state election office building to get a petition," Perkins said. "Then we drove straight here to set up and get signatures on my petition."

Just like with local elections in a county or municipality, a federal representative needs only 25 signatures to qualify to be on the ballot, but because District 8 includes part of Shelby and Tipton counties plus 13 other

counties that cover northwest Tennessee all the way to Henry and Carroll counties.

After getting his ballot, Perkins drove back not quite to his home in Memphis, but to Jackson, where he and his wife stayed for a couple hours in the conference room of the Jackson-Madison County Public Library while support-

ers whom he'd met had the opportunity to sign his petition.

"Our plan is to get more than 25 to make sure we have enough and then some in case some of the signatures aren't valid for whatever reason and get back to Nashville and file my petition (Friday)," Perkins said.

He was successful

in that endeavor, filing his petition and officially getting on the ballot for the Democratic primary.

"There are a lot of good people in District 8 who work hard and deserve to have someone fighting for them in Washington, and we don't have anyone fighting for us in Washington right now," Perkins said. "There's a monster in the White House, and one of his tentacles is right here in West Tennessee."

"It's time we cut that tentacle off, and voting him out is the way to do that."

Perkins said Kustoff has come up with some good ideas that he's tried to get passed in the House, but he said he gets talked out of his ideas by President Donald Trump and other members of the House and the Republican National Committee.

"When they do that, he takes opportunities away from our people here," Perkins said. "He takes money out of our pockets, food out of our children's mouths and resources away from our veterans who have served our country."

"We need someone who will fight for us and our people and to get District 8 what our people need to thrive."

Perkins said taking care of the vulnerable portions of the population is what the government should be doing.

"I think the measuring stick for a society is how it treats its babies, seniors, veterans and women," Perkins said. "We can be doing a much better job of all those things, so I want to raise the bar for District 8."

Business owners, former officials among known challengers for elected office

Here's a look at a number of notable people running for different offices and have at least pulled petitions for this year's elections.

County Commission District 1, Position 1

Lonnie Parker III is challenging for the seat after having submitted his resume to the County Commission last fall to fill the open seat left vacant by the passing of the late Luther Mercer. His wife is Sabrina Parker, the director of Helping Hands of West and Middle Tennessee and the Jackson Chapter of the National Action Network.

Tina Mercer, the incumbent for the position and daughter of Luther, has pulled her petition for the seat.

Both are running as Democrats

District 2, Position 1

Jennifer Greer has pulled a petition for this seat as a Republican.

Greer is the wife of Brad Greer, the chair of the Madison County Republican Party.

This is the seat vacated by Olivia Abernathy, who announced in November she wouldn't be running for re-election.

District 6, Position 1

Brian Wilson is running for the position being vacated by Jimmy Arnold, who isn't running for re-election. Wilson is a 30-year veteran of the Madison County Sheriff's Office who went to work for the County Highway Department after retirement.

District 6, Position 2

Current Commission member Arthur Johnson is resigning from the Commission at next week's meeting.

His nephew, Mike Bailey is running for the seat along with prominent South Jack-

son realtor Chris Phillips.

District 7, Position 1

Independent candidate Mitiz Merriweather is challenging Gary Tippet, and she works in the Jackson City Court Clerk's office and two of her children are City HR Director Kelsea Merriweather and construction business entrepreneur and former Harlem Globetrotter A.J. Merriweather.

Both were former standout athletes at South Side High and went on to play college volleyball and basketball respectively.

District 9, Position 1

Incumbent Karley Bond is being challenged by independent candidate Gina Langley, who co-hosts a morning radio talk show on WNWS-FM 101.5, Mike and Gina in the Morning.

District 10, Position 1

This is the seat vacated by Andy Hall, who's running for County Mayor.

Two Republican candidates have pulled petitions.

One is Karen Bell, a longtime friend of Hall's who's the former finance director for the County before she retired last year after a public disagreement with Mayor A.J. Massey and Jackson-Madison County Schools Superintendent Dr. Marlon King.

The other is Julie Wiser, the wife of Sheriff Julian Wiser.

General Sessions Judge

Incumbent Mark Patey has pulled his petition.

While she hasn't

pulled her petition, local attorney Jen Free has announced her candidacy and has announced a campaign kickoff event on Jan. 21.

Free was one of four other candidates who submitted their names to the County Commission last spring when they ultimately appointed Patey to serve on the bench after former Judge Hugh Harvey retired.

Whoever wins this election will serve the rest of the term Harvey was originally elected to serve in 2022 until 2030.

JMCSS Board District 5, Position 2

Marcia Moss is being challenged by independent candidate Sherry Franks.

Franks served for four years as the school board member for District 5, Position 1 before losing in the primary two years ago to Shane Barnes.

Jackson City Court Clerk

Jackson City Councilman Johnny Dodd has pulled a petition for this position after longtime clerk Darryl Hubbard decided not to run again.

Kim Condray, wife of former Jackson Mayor candidate Ray Condray, has filed her petition for the position too.

The deadline to pull and file a petition is Feb. 19. Once a petition is pulled, 25 signatures of registered voters within the district or county - depending on the position - is required for the person to be qualified for the ballot.

Condray running for City Court Clerk

Kim Condray has never sought out the limelight. She prefers being behind the scenes.

She stayed behind the scenes two years ago as much as possible, only stepping out a couple of times to join her husband for interviews some of the time.

But now she said she feels called to step out and has pulled a petition to run for City of Jackson City Court Clerk. She pulled the petition on Friday, and on Saturday morning, she was officially announcing it at the Madison County Constitutional Republican meeting. Two days later on Monday, she'd turned in her petition with all 25 signatures needed to qualify to be on the ballot in August.

Condray is the wife of Ray Condray, who campaigned for Jackson Mayor in 2023 and pushed Mayor Scott Conger to a runoff in June of that year before falling short.

"I watched Ray go through that campaign and was in it with him and gained so much respect for him than I already had," Kim Condray said. "And I never thought I might decide to do the same thing."

"And I really didn't decide to do it because I feel just like Ray felt God calling him to run for mayor,

I feel God calling me to this."

Darryl Hubbard is the longtime City Court Clerk, and he's announced he's not running for re-election, leaving the position open.

So far, Condray and Jackson City Councilman Johnny Dodd are the only two candidates who have pulled a petition for that position.

Condray moved to Jackson not long after she graduated college about 30 years ago.

"I've lived here ever since and love it here," Condray said. "I taught school for 12 years at the middle and high school level before I worked at different places in office administration."

Condray said she thinks her more than a decade of work in office management has given her quality experience to oversee the office that ensures the payment of fines from those with a

guilty verdict or plea in Judge Thomas Anderson's court room.

"I haven't seen a job description anywhere on the City's website, but it says there are only two requirements - to have a high school diploma and to be a resident of Jackson," Condray said. "So I guess I'm OK to run."

"But if elected, I plan to have a symbiotic relationship with Judge Anderson in not only handling the money into the City from the court to make sure it's not running in the red like I've been told it is, but also handling court dockets, managing records and filings and just keeping the public informed of what's going on in City Court because we need to know."

Hubbard currently has a staff of seven who handles the day-to-day duties of the office, and Condray said she plans to work with each of them as well to make sure the office is efficient for the City's needs and for the court's.

"I'm not a politician and have no interest in becoming one," Condray said. "I'm just a hard-working woman who feels called to help out in this area, and I believe I can do that. I ask the voters of Jackson to give me a chance and give the office a fresh set of eyes in looking over what the City has coming in."

One piece of advice for spelling bee contestants

A few members of the local media were at Rose Hill School Tuesday morning talking about the upcoming JMCSS Spelling Bee next week.

We were gathered in the library interviewing the school's librarian Krista Grace, the two young men who will represent Rose Hill in the district-wide bee and their teachers.

And it brought back memories of my own glory days competing in spelling bees.

And it also brought back the memory of when I first began to learn the importance of proper preparation.

It was February of 1995, and I was in eighth grade.

I was a good student when I wanted to be, and I had - at one time - a really good memory.

Spelling was something that I was better at than most academic subjects growing up, almost to the point that in elementary school when it was time each day to get out our spelling books and get to that subject for an hour or so, that was almost like break time because spelling was easy for me.

So in eighth grade, I won my school's spelling bee and would represent Cloverdale Junior High in the Lauderdale County (Ala.) Schools District Spelling Bee.

Winner would go to the state spelling bee in probably Montgomery or Birmingham.

I don't remember that part because I didn't need to know it since it had nothing to do with me.

At some point after I'd won the school bee, I was outside after school one day shooting basketball in my yard when a buddy came by riding his horse.

He asked me if I wanted to ride the horse for a minute, and I said sure because I thought we'd just go for a simple trot around my yard and then he'd ride the horse off down the road and I'd go back to shooting the basketball because my career plans at that point were to skip college bas-

ketball and be drafted by the Chicago Bulls and lead them to more championships than Michael Jordan ever did.

Except I got up on the horse behind the other guy, and he took off down the road like he was trying to win the Kentucky Derby.

I was beginning to panic and was trying to make sure I didn't fall off the back of the horse.

He thought I was trying to push him up to the horse's neck, so to keep from doing that he decided to jump off the horse at full run without telling me.

I nearly broke my neck as I hit our gravel road chin first. I can remember this experience in my mind and watching trees on our road go by while my chin slid on the gravel until the rest of my body fortunately fell forward, causing a lot of impact on my abdomen, creating a massive gash in my hip and peeling a lot of skin from my chin like an apple.

I've been in a few car wrecks - nothing more serious than a rear-ending - and I've never been as sore as I was after this experience. It happened on Tuesday evening, and I didn't go back to school that week.

But there was an issue ... the county spelling bee was that Thursday.

I didn't go to school that day, but my mother drove me to the event at a building on the campus of the University of North Alabama in Florence, and I proudly represented Cloverdale looking like my career plan was MMA and I needed to do a lot of work to improve.

It had also been a couple days since I'd looked at any of the words and hadn't even really

thought much about the bee until our school counselor called my mother at home asking if they needed to go with our school's runner-up for the event. I said, "I got this."

I made it through the first couple of rounds of words and I wasn't the first one eliminated, so there's that.

But then it was my turn on the third round through, and my word was "beryl."

That word is short for the chemical "beryllium," which is on the Periodic Table of Elements as the fourth square. I was familiar with "beryllium."

But when it's shortened to "beryl," the pronunciation changes, so I very confidently spelled out the word that I heard at that moment.

B-A-R-R-E-L. I was shocked when I'd spelled "barrel" wrong because they let me know the correct spelling, "beryl."

And that's how my spelling bee career ended ... in confused defeat because of a misunderstanding.

But you can ask for a definition. You can ask to use it in a sentence. I had options, and I took none of them because I didn't think I needed to. Because who doesn't know how to spell "barrel"?

So to all of the students in next week's spelling bee: I don't care if it's the word "I" or "a" or "the" or "it." Get the definition. Have them use it in a sentence. Get the origin. Ask for the first couple letters. Do whatever you can to make sure you're spelling the word they're reading every time.

Maybe you can go further than me. Because the winner of this bee has the chance to compete in Nashville for the chance to go to Washington D.C. and be on ESPN in the national competition.

people we were serving near in that country," Miller said. "And I not only worked with the people of the country, but I was working with translators too."

"And some of those decisions had to be quick decisions, so I did my best to talk with everyone and get their perspective before ultimately making whatever decision needed to be made at the time. I did it thoughtfully and prayerfully and feel like I gained respect from all sides when I did."

Miller said he feels like being able to bring that ability of diplomacy could work in his favor if he were to win election for this position.

"Four years ago

when I ran, I came in ready to change the world and thought I had all the answers," Miller said. "But that's not my approach this time."

"I've been watching and paying attention and seeing how this position needs to operate. For example, I came in last time thinking I knew what everybody and every community needed. But maybe what I think a certain area needs isn't what the people of that community needs or wants. That's why I plan to have town hall sessions and get out and meet people in areas like Medon, Three Way, Spring Creek and all these different areas of the county to see exactly what they want and why."

Many who spoke at the event on Miller's behalf spoke about his integrity, faith and compassion for others.

"I think all three of those characteristics are needed for this position because you want someone who has integrity in that role," Miller said. "And faith will play a very large part of every major decision I make in this position or otherwise."

"And when I'm mayor, I will be mayor for everybody and not just the people who voted for me or liked me. So when you need me, I'll be there for you making sure Madison County is there for you."

Sacred Heart's final graduating class before the closure of the school," a statement from Sacred Heart said. "We are devastated at the news of his passing in a senseless act of violence."

Andre Bell was a bright scholar and a kind gentleman, a tremendous athlete and a dear friend. He will forever be remembered and beloved by his Sacred Heart family. Our hearts

go out to his family and many friends, and we pray for the repose of his beautiful soul."

While at Sacred Heart, Andre was the recipient of the Ronald Reagan Leadership Medal.

"This award is given to the student who exemplifies the pillars of drive, humility, and service before self," the statement continued. "This student has the

conviction, ambition and courage to take initiative in their endeavors, possesses the unique combination of altruism and empathy, and serves selflessly in pursuit of prosperity for their fellow students and citizens.

"These rare and admirable qualities were exemplified every day by Andre Bell."

Bell was an one of the leading players for Sacred

Heart when the Knights were one of the best teams in West Tennessee. He was named to the Division II-A West All-District team.

"Andre was a smart, respectful young man who truly loved the game of basketball," said Nick Bearegard, the boys' basketball coach at SHJHS. "You could see that love in the countless hours he put into the gym, always working to get better."

"I had the privilege of coaching Andre for four years, and each year he grew not only as a basketball player, but as a student and as a young man."

No matter what was asked of him, Andre did it without hesitation, always responding with a simple, 'Yes sir.' Andre was deeply loved at Sacred Heart and will be truly missed."

Bell also played baseball for baseball coach and athletic director John Barlow.

"Andre didn't have quite as much experience playing baseball as he did basketball, but he was a great athlete who definitely helped the baseball team," Barlow said. "He played outfield and was good at making contact with the bat."

"He was usually quiet around me but always did his best to do whatever he was challenged to do in practice and in games."

Former Sacred Heart Principal Dr. Ann Keyl made a statement about Bell and his family that both coaches made as well.

"Andre was a good kid who always wanted to help however he could," Keyl said. "And his family did everything and was as involved with the school as they could be."

"I've talked with a lot of people who knew him, and this is a great loss for a lot of us."

Fisk University is feeling the loss of Bell.

"Our hearts go out to his family at this most difficult time," said Fisk Athletic Director Valencia Jordan. "We will stand with them and support them in every way possible. We are a family that learns, loves, plays, and prays together and will continue to do so. Counseling is being provided for our team of athletes who are understandably heartbroken."

The basketball team is missing a leader in every way with Bell's passing.

"He was a dominant force on the Fisk University Men's Basketball team, but he was most remembered for his infectious smile, loving personality, and unique ability to always bring warmth to a room," said men's coach Jeremiah Crutcher. "We now have a deep absence in our program, but more importantly, we have a deep pain in our hearts."

"He will be truly missed. Our thoughts and unwavering prayers are with his family and the little kids in his family and in Nashville who looked up to him."

Council approves bond issue, land sale at disc golf course

The Jackson City Council handled two high profile situations during their special-called meeting on Thursday, Jan. 8.

The first one was approving officially requesting the \$26 million bond issue they voted to do nearly a year ago.

Now that the audit for the City's finances for fiscal year 2024 is in, the City's finances could be properly evaluated to

determine the cost of the issuance.

The City Council, Mayor Scott Conger and City Recorder Nathan Reed had discussed possibly making it a 30-year bond, but they ultimately landed on a 15-year issue.

The \$26 million will be used to pay for a number of things the City needs to do including more than \$10 million in street repaving, which about half the Council members began discussing during the meeting specific streets

in their respective districts they wanted to

four-page document with 84 line items in 30 sections listed as possible items to be paid for with the money.

Some of the items on the list, however, are items the City has already paid for including the new risers that are being installed in the Carl Perkins Civic Center. Others are items that were proposed and discussed but have since been taken off such as the City's contribution to a homeless shelter.

Here's a look at the

biggest items that cost more than \$1 million:

- \$1,634,175 for 18 new cars for Jackson Police
- \$4,900,000 to put artificial turf on the infields for all fields at the West Tennessee Healthcare Sportsplex
- \$2,500,000 for Phase I of the re-building of Airways Boulevard that's set to begin in spring of 2027

Local disc golfers oppose potential land sale on municipal course

Editor's note: This story was written from an interview on Jan. 7, the day before the Jackson City Council's special-called meeting on Jan. 8. The issue was resolved during the Council meeting but posted here now to show the story and work put in by the local disc golf group and their perspective on the situation.

golf course.

The land was given to the City when the golf course closed, and since then the Jackson Tennis Complex has been constructed there and different businesses have been housed in the course's clubhouse.

"A lot of people are confused because when you drive by it on Highland Avenue you see a bunch of big for sale signs in the front," said Thomas West. "But the only land that's for sale is the property within a couple hundred feet of the street that would be big enough to put a couple of businesses next two right on the highway."

"Everything else is the City's and The Bend."

West is the leader of the local Jackson Disc Golf group that's made of local disc golf enthusiasts.

West got into the sport after graduating from South Side High School in 2005 and has since continued to play.

In 2021, he approached the City's parks and recreation department on behalf of the disc golf group about converting High-

land Green into a disc golf course, and after about a year of discussion and preparation, it happened.

"And we've been rolling since then," West said. "Our group has a lot of people who play there on at least a weekly basis, and we've got a number of people who drive from Nashville or Memphis or from one of the nearby states to Jackson just to play this course."

The course was also the site where the inaugural Tennessee State Games disc golf competition happened in June of 2025 and where it's slated to happen in 2026.

But those plans were put in limbo in the last few weeks when an offer the developers of The Crossings, which is adjacent to The Bend, to purchase 13 acres of land.

According to statements made during Tuesday's meeting, The Crossings (Joel and Shane McAlexander) and neighboring developers of Windstone (Kenny Southerland

Property taxes, healthcare, education discussed by state legislators

The Southwest Tennessee Developmental District hosted its annual gathering of state legislators in the area with local mayors and other leaders from different counties in the region to get an idea of what their plans are for the upcoming legislative session that begins on Tuesday, Jan. 13.

Both of Madison County's State Representatives Johnny Shaw (District 80) and Chris Todd (District 73) were a part of the panel as well as Madison County's State Senator Ed Jackson, who joined virtually as he was en route to a committee meeting in Nashville at the time.

State Rep. Brock Martin (Huntingdon) was also a part of the panel.

Todd spoke about a month earlier at another event about his plan of sponsoring a bill that would put an end to state property taxes, and he continued to speak on that at this event.

"I've had a number of people - particularly seniors and veterans who are on fixed incomes - who are concerned about taxes going up and not sure how they're going to make it because their income isn't going up with them," Todd said. "And I feel like this is one way to do it."

"Because those of you in this room who own property, you paid for it and have the paperwork for it, but you still pay on it every year. And if there's a way we can do away with that and from the state perspective and not lose any funding for our state and local governments, I want to try to do that."

Todd's proposed method is to increase the state sales tax by somewhere in the 4- to 5-percent range and get it to about 14 percent.

"We put our economic people on it to see what kind of a raise we'd need in sales tax to continue to keep having that revenue, but just coming from another stream, and 14 percent appears to be about where it needs to be for us

to continue to have that," Todd said. "And we're looking at what all would be taxed, because if we can get it without putting a tax on groceries, I want to do that too because groceries are already expensive enough as it is."

Todd assured all the mayors in the room that under his proposed plan so far that their respective entities would continue to get the same amount of money from the state they're getting now simply coming from a different pot. And if at any point they needed more money, they could simply apply for that extra funding with the state legislature.

of the trucking company that transported those potatoes in from Idaho or wherever and their property tax. Then another part goes toward the property tax for Kroger or whichever market you get your potatoes from. And Kroger also pays property tax on the land, the building, the shelves the potatoes are sitting on when you pick them up, the equipment that's used to purchase them and the property taxes the employees pay to get those potatoes out there for you, get them purchased and get them to your car. So we're all paying property tax, but we're probably paying more property tax than we realize."

Todd also addressed the notion of a sales tax increase.

"We've talked with a few economic people about this, and they looked at the situation in our state," Todd said. "And they said, 'OK, you have 14 percent sales tax, but you have no state income tax and in this scenario you have no state property tax,' and they said that was a no-brainer."

"That would be a good move for everyone because it would be the people who are actually spending the money who are paying the taxes and not risking putting it on a large portion of the people who own property who aren't getting raises to keep up with tax hikes from the state or lo-

State legislators: Great Wolf Lodge construction plans in bid phase

Great Wolf Lodge is nearing the construction phase.

State Representative Chris Todd and State Senator Ed Jackson were both speaking as part of the panel at the Southwest Tennessee Developmental District's (SWTDD) annual discussion for West Tennessee legislators with local leaders at the county and city level.

When a question from the crowd came up about tourism, Todd's answer discussed a number of things happening that could increase tax revenue from tourism.

Todd mentioned Great Wolf Lodge.

"I've received a planning file with literally 1,200 blueprint pages of what they plan to do, and those blueprints included plumbing, electrical and that sort of thing," Todd said. "So the project is moving forward."

Great Wolf Lodge officially bought the property for a Jackson location near Liberty Tech High and Jackson Baseball Stadium in November of 2024 and did a lot of dirt-moving work last year.

Great Wolf Lodge is a national brand resort hotel with an indoor water park. In February



of 2020, The Greater Jackson Chamber in conjunction with Great Wolf Lodge announced the resort's intentions to put a location in Jackson complete with money earmarked in that year's state budget for help for the company in their costs to locate in the Hub City.

The following month is when the shutdown happened for COVID-19, which put a pause

on the Lodge's plans to come to Jackson and actually moved the project down on their priority list.

Over the years, the project has moved up the list as they've secured their plans and completed projects for new locations in other states.

The next phase is to lay the foundation and infrastructure for the hotel/water park and begin to build up from there.

Madison County Mayor A.J. Massey said during his State of the County address at Jackson Exchange Club on Tuesday, Jan. 6, that he knew there were plans

that had been sent out to potential bidders.

On Friday, Jan. 9, Ed Jackson confirmed that statement.

"The work is up for bid, and from my understanding, there are really only two contractors who specialize in this work because of the volume of water Great Wolf Lodge will use," Jackson said. "And both of those contractors have those plans."

Greater Jackson Chamber President Kyle Spurgeon was also present for the meeting on Friday at SWTDD, and after Todd and Jackson had made their statements, the floor was offered to Spurgeon if he

wanted to expound on what they'd said.

He declined to give any more specific information, but he did use a sports analogy to describe where the process is.

"We've been in this conversation for seven years now since Thanksgiving of 2018, and there have been times we felt like we were first-and-goal and then we'd get backed up," Spurgeon said. "I can tell you we're in the red zone and getting closer and closer to the goal line, but we're not quite there yet."

How NOT to respond when people are hurting

A tornado rips through a small town leaving nothing but debris in its wake.

A vacation trip turns tragic with the disappearance of a young child.

inflating our sense of self-righteousness, we magnify the perceived inadequacies of those in the fires of misfortune. Driven by inward arrogance and outward apathy, our presumption reeks of sanctimonious foolishness.

Considering these dangers, allow me to offer a necessary biblical principle to remember when hardships arise. Namely, the presence of tragedy does not reveal the presence of sin. In Luke 13 Jesus addresses a well-known atrocity that left the Galileans bewildered and confused. Apparently, Pilate killed a group of Jews who were making sacrifices in the temple because he suspected them of sedition. Unfortunately, the common belief then, and even today, was that victims of such calamities were guilty of extraordinary sins.

Though these attitudes won't cause us to stumble when we aren't on the receiving end of calamity, there are other temptations when we witness others hurting. Most of us would never vocalize our darkest thoughts, but sometimes we sit in judgment over the misfortunes of others as if they are deserving of the difficulties we avoid. By

who were not. The positive or negative nature of a people's circumstances is not an indicator of their need or lack thereof for repentance.

Jesus simply answers, "Unless you repent, you will all likewise perish (Luke 13:3)." Then, to drive the point further, our Savior shares another example about the danger of presumptuous interpretation when trials come. When a tower in Siloam fell and killed eighteen people, Jesus again refused to make reckless judgments (Luke 13:4). Though our Savior does not deny that some events are acts of judgment or that sin often causes pain, He does insist that we should never feel safe or proud because bad things do not happen to us. Again, He simply retorts, "Unless you repent you will all likewise perish (Luke 13:5)."

My first reaction to any disaster should not be a moral evaluation of those who suffer and those who do not. Many wicked people live carefree lives, and many good individuals face immense challenges. Could it be that God sometimes uses calamity to bring those of us who are spectators to repentance rather than to punish those who are immoral? Do bad things sometimes happen for reasons we do not understand? The painful realities of a fallen world should lead to our humble repentance rather than our boastful reassurances.

So how should we respond to blessings, trials, and hardships?

First, we should humble ourselves. Humble yourself before God and yield to His plan even when

you are hurting. Humble yourself if you emerge unscathed after life's storms. Humble yourself as you enjoy the blessings of safety and tranquility. Refuse to use God's blessings as an occasion for boasting.

Second, we should pray for our neighbors when they hurt. Pray for wisdom about how you might encourage them. Pray that God will bring our community together when we face difficulties. Pray for a deeper, more sincere walk with God. Pray with thanksgiving for God's mercy and protection each day of your life.

Third, we should love more. Love God more than you did before your life fell apart. Love your neighbors as yourself when they suffer. Love your community and friends as precious parts of your life. Love your enemies when tragedies strike by burying past grudges. Love your place of worship and the believers there.

Finally, we should thank God. Ask Him to make you more aware of the blessings you take for granted. Thank God for His protection and care over the course of your life. Thank God for His unconditional love. Thank God that our circumstances do not reflect our eternal value. Thank God for the strength to endure our worst days.

Choosing grace in a cynical age

We are living in a moment where suspicion often feels like the default posture. We assume motives before we ask questions. We scroll past one another's humanity. We brace for disappointment before we allow ourselves hope. Cynicism has somehow been reframed as wisdom, and grace as naïveté.

But what if the quiet work of culture-building begins somewhere much smaller? What if it begins by assuming the best?

Assuming the best does not mean ignoring harm, denying reality, or refusing accountability. It means starting from a place of generosity rather than judgment. It means believing—at least initially—that

most people are doing the best they can with what they have. The writer Anne Lamott once said, "Almost everything will work again if you unplug it for a few minutes, including you." That's true of people, too. Grace creates space for recalibration.

Giving grace is a countercultural act. It slows us down. It requires patience. It asks us to resist the easy satisfaction of being right in favor of the harder work of being kind. The theologian Miroslav Volf wrote that grace is not a denial of justice, but its fulfillment—because justice without mercy often becomes cruelty. In everyday life, grace looks less like grand gestures and more like small, quiet decisions: choosing not to escalate, choosing to listen, choosing not to as-

sume the worst.

And perhaps that's where culture is really shaped—in the small things.

Culture is not only formed in institutions or headlines. It's shaped at dinner tables, in parking lots, in text messages that could have been sharp but weren't. It's shaped by how we speak to baristas, how we respond to disagreement, and how we treat people who can offer us nothing in return. The poet Mary Oliver once asked, "Tell me, what is it you plan to do with your one wild and precious life?" One answer might be: pay attention.

Taking notice is an act of resistance in a distracted world. Noticing when someone is struggling. Noticing when someone shows up faithfully without recognition. Noticing beauty that doesn't demand applause. The writer Frederick Buechner described vocation as "the place where your deep gladness and the world's deep hunger meet." Often, that meeting point is found not in sweeping change, but in attentive presence.

Faith traditions across time echo this same invitation. The prophet Micah distilled a complex religious system into something remarkably simple:

"Do justice, love mercy, and walk humbly." Justice, mercy, humility. None of these are loud virtues. All of them require us to see one another clearly—and generously.

Humility, in particular, asks us to admit that we do not have the full story. That the person who cut us off in traffic, missed a deadline, or spoke with perceived rudeness may be carrying burdens we cannot see. When we assume the best, we refuse to reduce people to their worst moment.

This does not mean excusing harm or avoiding hard conversations. Grace does not eliminate boundaries. But it changes the tone. It allows correction without contempt. It keeps relationship at the center rather than winning.

In a culture that rewards outrage and insists on speed, grace feels slow and inefficient. But it may be the only thing capable of sustaining us. The small things—gentle words, patient listening, unearned kindness—accumulate. They shape the air we breathe together.

Perhaps culture does not change through force, but through fidelity. Through people who quietly choose to assume the best, give grace, and pay attention—again and again.

And perhaps that is enough to begin.

North Side boys riding full-court defense to high ranking, winning record

HENDERSON – North Side's boys' basketball team started the first week of the TSSAA basketball polls ranked No. 2 in the state in Class 3A behind top-ranked Upperman in East Tennessee.

The Indians are highly ranked because they're 14-1, and they got their first district win on Friday, Jan. 9, on the road at Chester County, 72-22.

The game was a dominating performance in which the Indians made their full-court defensive pressure almost look easy, particularly in the second half when they outscored the Eagles 42-4

and didn't allow them to score in the fourth quarter after the mercy rule running clock had started.

"We go full speed all the time," said North Side coach Aaron Woods. "In practice, in every game, we take no time off because we want that do-or-die-now mentality and for it to be ready to go when we need it and not hope we have it when we need it."

The press frustrated the Eagles throughout the night. The Indians picked up 18 steals on the night as a team, most of which led directly to points on the other end of the floor.

There was a stretch of five consecutive Chester County possessions

in which the Eagles were doing good to get it to the half-court line, but the ball never made it inside the 3-point line as North Side picked up a steal before they could and quickly got back down the court for a basket.

And while the press was the main catalyst that propelled North Side to dominance on this night, it wasn't the only thing that helped them to the 50-point victory.

On the offensive end of the court, they were 9-for-19 from the 3-point line including 6-for-7 in the second half.

"This team works so hard, and they're starting to see that work pay off," Woods said. "We

Young talent raising bar for Liberty girls

LEXINGTON – Liberty Tech girls' basketball player Rakeryia Clinton stood at the free throw line during the Lady Crusaders' 51-50 win at Lexington in overtime on Jan. 2.

With 6.2 seconds left and Lexington up by a point, Clinton was fouled. She hit the first shot, tying the game and putting it on the verge of going to a second overtime.

Then Lexington called timeout. Clinton walked to the sideline to get in the huddle with her teammates and the coaches before head coach Brian Lake sent her back to the free throw line.

"I didn't want her thinking about anything but hitting that shot," Lake said after the game.

That's what Clinton did during the somewhat awkward minute-plus of time she stood there by herself at the free throw line with the crowd yelling, music playing over the loudspeakers, officials standing at their necessary spots during a timeout in that situation and both teams in their huddles in front of their respective benches.

"I just stood there and thought about the shot and what I had to do to make it," Clinton said. "I tried not to think about trying to win the game or

what a win would mean or anything like that. I just focused on making it."

Eventually the timeout ended and the music died down. The players returned to the court, and one of the referees gave Clinton the ball. After a couple of bounces on the court, Clinton's shot sailed just over the front of the rim and fell for a basket to give Liberty the lead.

The final six seconds of overtime took more than six real-time minutes to play because of timeouts and a couple of challenged calls on an in-bounds pass, but Clinton's free throws were the final points of the game, giving Liberty the win in a season in which the Lady Crusaders are now 11-5.

To put that record into perspective, the last three seasons of Liberty girls' basketball have combined for seven total victories.

So what's the difference for the Lady Crusaders

this year?

"We had a lot of talent come in this year," Lake said. "North Parkway Middle had a really good team last year, and all eight of their eighth-graders said they wanted to stick together in high school, and they all came here."

Six of those now-freshmen play significant minutes for the Lady Crusaders, and one of them is Clinton with her ice-cold water-in-her-veins free throw shooting.

"We like playing for Coach Lake because he does a good job of instructing the game and preparing us for each opponent," Clinton said. "And every

Niven living up to taller role for TCA

Zack Niven knows where he's headed with the game of basketball.

The son of Union University men's basketball coach David Niven, the younger Niven is in his senior season of playing high school ball at Trinity Christian, and he's

committed to play for his father and the Bulldogs.

While he knows what his plans are for next year, he's grown into his new role for the Lions this year.

During the last couple of seasons, he was the starting center for the Lions after hitting his growth spurt and now stands at 6-feet-8-inches tall.

He's been the presence under the goal for the Lions while sharpshooters in last year's senior class did the bulk of the heavy lifting on the scoreboard.

But now that those scorers are gone, a lot of the scoring opportunities have come his way, and he's taking advantage of that.

His averages are a little more than 20 points per game, nearly seven rebounds and nearly four blocks. He actually had 11 blocks in one game early in the season, setting a new school record.

"We had some really good players last year who were great at scoring, and my primary role

was rebounding, defense and scoring myself," Niven said. "But (TCA head coach Dexter Williams) and I had a conversation early in the offseason - probably not long after last season ended - about how I was going to need to step up in scoring."

"And I was ready to do that."

Niven and fellow senior Gabe Lee are the main two scorers for the team as both can be counted on for at least 15 points per night if not 20 while the rest of the team has about six or seven other players who each have scoring ability too depending on who has the hot hand that night.

Because TCA is relying more on Niven's presence in the post, that has changed their offensive methods as Lee is the main one shooting from the outside this year in-

stead of having three or four shooters on the floor at any given time.

But Niven said he enjoys the physicality that comes with playing in the post and being one that gets plenty of chances to score and be a factor for his team.

"I don't think of it as more pressure, but just a change in my role," Niven said. "If you want to look at it like pressure, then I put the pressure on myself all along to do my job for the team the best I could no matter what that job was."

His job now is to show up more in the box scores leading his team in points, rebounds and blocks.

"He's definitely embraced the role not just as the scoring leader for

In these fraudulent calls, scammers pose as MCSO deputies and falsely accuse the recipient of failing to appear for jury duty, have unpaid traffic citations, or have had official documents to serve the individual with. Victims are then given specific payment instructions, which may involve withdrawing cash from an ATM, sending a money order, or purchas-

ing gift cards. The scammers claim this payment is necessary to resolve the supposed court matter.

The Madison County Sheriff's Office wants to stress that it will NEVER make such calls or request any form of payment over the phone. No legitimate MCSO deputy will ever ask for cash, and any website provided for online payments by scammers is fraudulent and should not be visited. JMCSS hosting district-wide spelling bee

The Jackson-Madison County School System hasn't had a district-wide spelling bee in more than 20 years.

That's changing next week as the auditorium at Liberty Tech will be the site of the JMCSS spelling bee.

Students in third through eighth grades have competed in school-wide spelling bees to determine their school champions that advanced to the bee at Liberty.

The winner from that will have a chance to advance to regionals.

"The way it works are there are a large number of districts who have spelling bees, and the

winners of those are eligible to compete at regionals in Nashville," said Krista Grace, the librarian at Rose Hill School who's the coordinator and head judge for the district-wide bee. "But they only take 50 competitors in the actual competition, so the district winners have to take a test to qualify for the regional."

"Then the top 50 from the written test compete in Nashville."

The winner from Nashville moves on to the national spelling bee in Washington D.C. that is broadcast each year on ESPN.

Because elementary and middle schools are eligible to each have a representative in the

district bee, three K-8 schools - Rose Hill, Community Montessori and Pope - get to have two students compete at Liberty, one each from elementary and middle school grades.

"Spelling is really a

hobby for me," Calixto said. "I feel confident when I go into spelling bees that I'm going to win and I do my best because I know I've tried to learn as many words as I can."

"He calls out the words to me, and I try to spell them," Hays said. "And spelling is easy for me."

Both said they're looking forward to the district competition next week.

Terri Tims is Hays' English teacher and said she's proud of him, but she also can see a correlation between students who do well in spelling and students who excel in the classroom.

"Spelling is foundational for reading, and reading is essential for learning," Tims said. "And competitions like this are good for the scholars because it motivates them to do well."

Tiffany Rechis is Calixto's homeroom and math teacher, and she taught him in second grade too.

"Josue has always been a great student who picks up on most subjects quickly, and I think that ability has helped him become an excellent speller," Rechis said. "He's one of our top students in math too."

Conger said it will take a couple of years for some of the money - such as the funds earmarked for Airways - to be spent because of the timing of the projects.

The turf will be installed at the Sportsplex in two phases during the two times of the year they're not hosting tournaments every weekend, which is in the middle of summer between spring and fall seasons and in the middle of winter when fall ball has wound down and before spring season starts.

Council member Larry Lowrance asked about how much the interest on the bond would cost and also asking about if there had been any consideration about borrowing the money in smaller chunks instead of getting it all in one big lump sum on Jan. 22 or 23.

Conger said any money not immediately spent would gain

interest while sitting in the bank and be invested similarly to how Madison County Trustee Billy Burkhead invested the \$48 million the County had set aside and partially borrowed for Pope School construction and made a few million dollars back on that before that money needed to be spent on the project.

The bond issue was approved by a vote of 7-1 with Lowrance being the dissenting vote and Russ McKelvey being absent for the meeting.

The other significant conversation was about the proposed sale of nine acres on the disc golf course at the former site of Highland Green Golf Course adjacent to The Crossings. Before the meeting, Parks and Recreation officials met with the developers of The Crossings - Joel and Shane McAlexander - and Thomas West with the local disc golf group to see if an agreement could be met.

Whitacre to speak at Union's annual Faith in the Marketplace luncheon

Union University's McAfee School of Business will host Mark Whitacre, the highest-ranking executive in U.S. history to become a whistleblower, for its annual Faith in the Marketplace luncheon Feb. 10.

Whitacre's extraordinary true story inspired the Matt Damon film "The Informant" and the Discovery Channel documentary "Undercover," recounting his role as the FBI's key informant during the Archer Daniels Midland price-fixing scandal in the 1990s.

Drawing on more than two decades of executive leadership, extensive international business experience and undercover work, Whitacre now speaks on ethics, leadership, integrity, redemp-

tion and the central role of his Christian faith played in his personal transformation and second chance.

About 100 gather in Downtown Jackson to protest ICE

Indivisible Jackson had already planned to gather in Downtown Jackson near Jackson City Hall and the Madison County Courthouse for a peaceful demonstration.

“Originally, we had two ways people could choose to approach this protest,” said Cindy Boyles, the coordinator of Indivisible Jackson. “They could either have a positive approach with ‘Rise into the New Year’ or a negative tone with ‘Scream in the New Year.’

“And we had I think 47 people already signed up to show up for this one a week out from it, which would’ve been a good showing for us if everyone showed up.”

Then last week happened and the events of Wednesday, Jan. 7, in Minneapolis in which a federal ICE agent shot the driver of a vehicle three times, sparking protests and outrage across the country.

Video from the incident showed the driver of the car moving the vehicle either away from ICE agents or into another agent, and the agent who could’ve been hit by the vehicle fired three shots through the windshield at the driver, killing her. Her name was Renee Good.

In the wake of that incident, the national Indivisible organization began to change the common thread of this past Saturday’s protests as “ICE Out for Good.”

Despite cold temperatures and a wet forecast for

the afternoon, Boyles said they counted about 100 people who showed up in Jackson, made of mainly people from Jackson and others from around rural West Tennessee.

“There was one couple from Canada who were in Nashville vacationing

and were open to joining a protest on their vacation Saturday, but nothing was planned in Nashville,” Boyles said. “Then the Nashville group put one together and announced it early Saturday morning, but this couple had already committed to coming here,

so they came on down to West Tennessee and joined us.”

The group was on the sidewalks on Highland Avenue in Downtown Jackson

with signs and messages.

Boyles said the overwhelming response from drivers passing by was positive with a lot of encouragements and agreements with a few people who disagreed.

“I think if nothing else, our protests show people who agree with us that they’re not alone in a part of the state that is conservative and heavily agrees with the President’s policies,” Boyles said. “I know from some of our past protests, we’ve had people from the smaller, more rural areas who felt like they were alone in their beliefs found out there are many like-minded people who agree with them and want their voice to be heard.”

cal governments.”

Speaking of local taxes, Todd also mentioned the bill he sponsored last year and plans to continue to do so this year that would put a cap on how much local tax rates can increase after apparently one community in the state raised taxes by more than 160 percent in one year. He mentioned Davidson County has increased taxes by more than 50 percent in three years.

“I want us to put a cap on that, but I also want to make sure we’re not incentivizing local governments to raise their taxes incrementally each year,” Todd said.

Martin, who is a doctor in his day job and the chair of the health committee, said the main thing that committee is doing this session is trying to

decide what to do with the \$208 million Tennessee is receiving from the federal government as part of the One Big Beautiful Bill that is earmarked for rural health.

“Rural health is certainly an important issue across the state, and there are a number of ways we can address it,” Martin said. “But we’ve got to make sure we spend this money wisely because it’s only a one-time funding, so we need to make sure we get the best return on that investment with the wisest way to spend it.”

He noted that in his home area, there was a time where pregnant women had two birthing centers in Carroll County in Huntingdon and McKenzie to choose from to have their baby and get their prenatal

care. Both of those units have closed down along with a neighboring one in Paris in Henry County, so their two main options are in Jackson and Martin, which is not an ideal situation.

“There are other counties in the state whose pregnant women will have to travel further to one option,” Martin said. “We’re glad we have two.”

Shaw’s portion of the panel began with letting the mayors know he wanted to hear what they had to say about Todd’s property tax plan before he casts a vote on it whenever it would come up in the State House.

But probably the main thing he discussed was his plan to sponsor a bill that would streamline the process for churches who wanted to start their own

private school to be able to do that.

“A lot of parents are homeschooling their children because they don’t trust what’s going on in our public education system, and churches including the one I pastor are looking into starting a private school,” Shaw said. “So I’m looking to do that.”

When asked about it later, he said these schools would need to be in line with state educational standards to be able to exist, but he sees the need for different options for families without necessarily taking funding from public schools.”

Shaw also received a round of applause when the meeting recognized the fact that this will be his final session in office as he’s not running for re-election

after having been elected to the seat 13 times for 26 years.

Jackson started his portion of the discussion by informing the gathering he’d picked up his petition for re-election at the Madison County Election Commission before leaving town that morning.

The two main things he discussed were his perspective on the proposed Juvenile Justice Center Madison County that Mayor A.J. Massey, Judge Christy Little and Juvenile Justice Services Director T.J. King have been working on for years. Jackson said he’s confident there will be a significant amount of funding for the center in the state budget when it’s needed.

Jackson also discussed how the state is working

with Christ Community Health in East Jackson to provide another option for dental, maternal and mental healthcare for underserved citizens in the area.

“With dental, Christ Community just opened up a dental facility in Obion County, and before that, if a person couldn’t afford dental care, they just didn’t go until they got to a point they had to go,” Jackson said. “And then they were going to the local emergency room.”

“So we’re giving citizens an option there right here in Jackson, and we appreciate what Christ Community Health is doing.”

The session starts on Tuesday and is expected to be done before the end of April.
